The accounting method has been changed from a proportionate accounting treatment to equity accounting

The annual amounts in 1.4 relates mostly to prior year interest on the Palabora project.

The amounts in 1.25 are loans made to subsidiary companies and a joint venture entity. The amount is eliminated on consolidation, hence the difference to the amount reported in 1.11, which is after consolidation of the eliminating entries.

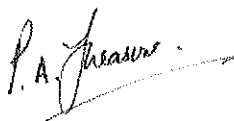

### **1.7 Other (Additional details)**

In the current quarter and year to date, there were exchange gains made due to cash balances held in the Canadian Dollar and South African Rand. In the current quarter there was an exchange loss of A\$ 37K and a net exchange loss for the year-to-date of A\$ 213K.

### **3.1 Loan facilities**

In October 2007, the entity issued convertible notes totaling A\$ 3,500,000. The notes have a term of three years, bear interest at 12% per annum, payable quarterly and are secured by a subordinated fixed and floating charge over the assets of the entity. The Note holders can convert the notes 180 days after issuance and prior to maturity to common shares of the entity at A\$0.50 per common share. The notes are redeemable by the entity, in multiples of A\$500,000, within 12 months from the date of issue. Upon conversion by the Note holder or redemption by the entity, the entity will issue to the Note holder one common share option for each A\$0.50 of the loan amount converted or redeemed, exercisable to purchase one additional common share of the entity for two years at A\$0.50 per share.
